2. Applications should be submitted strictly as per attached proforma, neatly typewritten/computer types alongwith one passport sized photograph. A latest passport size photograph duly attested by a Gazetted Officer may be affixed on the application.
3. The Institute has the right to fix criteria for screening the application so as to reduce the number of candidate to be called for interview.
4. Unemployed SC/ST candidates called for written test/interview for the post will be paid traveling expenses equivalent to second class railway fare as per GOI rules.
5. Application Fee of Rs.50/- (No fee for SC/ST candidates) in the form of Demand Draft/Pay order in favour of ICAR Unit, CPCRI, Kasaragod may be enclosed alongwith application.
6. **Original certificates and mark sheets should not be submitted alongwith the application** but should be brought as and when called for selection process. Attested copies of certificates regarding age, educational qualification, experience and caste etc. should however, be submitted along with the application.
7. No correspondence will be entertained with the candidate for being called for written test/interview. Canvassing in any form will disqualify the candidate for the post applied for.
